They will write a check to the company or pay it online(all receipts will be kept for our records). We are able to purchase Wal-mart gift cards for up to \$240.00 but they will have to bring in the receipts and they will have to sign an agreement. They can't purchase alcohol or tobacco products. If any of these items are purchased they are automatically

disqualified from the program. The gift card will have to be brought back into the office each month to be reloaded. Trustee Allen wants to know can we help with transportation (gas and metro cards). Alicia said "Yes."
